DISCLOSURE AND CONSENT TO RECEIVE ELECTRONIC DELIVERY OF RECORDS ("AGREEMENT")

Please read this Agreement carefully, print a copy, and/or retain this information electronically for future reference.

1. DEFINITIONS.

The following words and phrases shall have the meanings given to them, unless the context clearly indicates otherwise:

"Modern Woodmen," "We," "Us," or "Our": Modern Woodmen of America, 1701 1st Avenue, Rock Island, IL 61201. "Modern Woodmen" shall also include Modern Woodmen's subsidiaries and affiliates.

"Agreement": This Disclosure and Consent to Receive Electronic Delivery of Records form.

"Certificate": A contract of insurance or an annuity between Modern Woodmen and You.

"Records": Any and all disclosures, declarations, contracts, Certificate forms, claim forms, illustrations, Certificates and/or documents, information, requests, Certificate applications, communications, terms, reports (including annual reports), and/or notices (including premium due notices) required by state or federal law, including, but not limited to, any adverse action notices or privacy policy notices. "Records" does not include notices indicating the cancellation, nonrenewal, or termination of health insurance or benefits or life insurance benefits (excluding annuities).

"You," "Your," or "Owner": The person(s), entity, or interest described in any ownership and control provision of the Certificate(s) associated with the Modern Woodmen member account accessed to initiate this Agreement.

2. INTRODUCTION.

From time to time, to the extent permitted by law, Modern Woodmen may use the Internet, electronic mail ("email"), digital media, or other electronic means to transmit Records and/or related information to you as an owner of a Modern Woodmen Certificate or other product, including by sending notice to You via email containing a link to a Record available through a secure log in to Modern Woodmen's member website (accessible from www.modernwoodmen.org) or Modern Woodmen's mobile application. Modern Woodmen may also send You Records via email as text or attachments to such emails. This Agreement informs You of Your rights when conducting these transactions electronically with Modern Woodmen.

If You reside outside of the United States, You may not consent to receive electronic delivery of Records. Paper copies of Records will be sent to You if You reside outside of the United States.

4. HARDWARE AND SOFTWARE REQUIREMENTS.

To retain Your Records, Your access device must have the ability to download to Your hard drive, or any external media storage, or to print the Records, as well as embedded HTML files.

If, after You have consented to the terms and conditions of this Agreement, a change in the hardware or software requirements needed to access electronic Records creates a material risk that You will not be able to access or retain subsequent electronic Records that are the subject of this Agreement, upon request Modern Woodmen will provide You with a statement of the revised hardware and software requirements for access to and retention of the electronic Records, and the right to withdraw Your consent without imposition of any fees for such withdrawal and without imposition of any condition or consequence that was not disclosed under this Agreement. You will receive any Records required by and permitted to be received by electronic delivery by state or federal law through the Modern Woodmen member website, mobile application, or email address you provide. If a law requires Us to provide, send, or deliver information in writing to You by a specified manner, such as by U.S. mail, We will continue to do so.

6. OPTION TO OBTAIN PAPER COPIES OF RECORDS.

Modern Woodmen will only transmit Records related to Your Certificate(s) through electronic delivery if You consent to such delivery via this Agreement. **Your consent is voluntary**. You have the option to request that Modern Woodmen provide You with paper copies of those Records We provide to You electronically through the Modern Woodmen member website or mobile application, the email address You provide, or another electronic means. 7. RIGHT TO WITHDRAW CONSENT AND PROCEDURES FOR WITHDRAWAL.

Your may withdraw Your consent or "opt out" of receiving Your Records electronically at any time by updating Your preferences on Your Modern Woodmen member account by logging into Your account at www.modernwoodmen.org or by logging into Your account by using the Modern Woodmen mobile application. Once You withdraw Your consent by updating Your preferences, with the exception of email communications, communications and delivery of Records to You will continue to be processed in non-electronic form at no charge. Withdrawal of Your consent shall not affect the legal effectiveness, validity and/or enforceability of Records provided or made available to You via electronic delivery prior to implementation of Your withdrawal of consent. Your withdrawal of consent shall be effective within thirty (30) days after receipt by Modern Woodmen of Your withdrawal request via Your preferences updates.
